Police Chief Colin Rangnow advised Council the Police Department is in need of new AC/Heating package units that service the downstairs area of the Department. He said at least two (2) of the units are inoperable and the remaining units continue to have ongoing maintenance issues and several of the units are inundated with rust which results in roof leaks. He stated the Department has experienced roof leaks over vital areas, dispatch and the 911 equipment closet, as a result of the rusted AC/Heating Units. He said it is vital to the Department to have adequate cooling to maintain electrical operating systems.

Quotes for Police Department includes five (5) 5-ton gas/electric roof-top units, all necessary electric work, gas line disconnects and re-connect, installation of said units and removal of older units, curb adaptor and lift crane service. Staff recommends Coastal Refrigeration for \$26,935.
