CONSIDER RECOMMENDATION OF PORT COMMISSION FOR A GROUND LEASE AGREEMENT BETWEEN THE CITY OF PORT LAVACA AND NEVAREZ INCORPORATED EVELYN'S SEAFOOD MARKET ON TRACT OF LAND LOCATED AT PORT LAVACA MUNICIPAL HARBOR, CITY OF PORT LAVACA, TEXAS, IDENTIFIED AS TRACTS 7, 8 AND 11

This is an interlocal agreement that has been continued between the CCISD and the City for numerous years. This year both parties agreed to add an automatic renewal clause instead of having to bring it before Council every year.

CONSIDER AWARD OF CONSTRUCTION CONTRACT FOR FLOORING WORK AT NAUTICAL LANDINGS MARINA OFFICE

City Engineer/Community and Economic Development Official Weaver advised City Council that the hurricane damaged flooring in a small room of Suite 3 and the east part of Suite 4. These two suites were bid separately and awarded on a Purchase Order less than \$5,000 and will be completed on February 16. She said these repairs were needed as the result of hurricane damage and should be eligible for 90% reimbursement from FEMA.

Weaver also reported on bids for Suites 2, 6 and 7 and the Bid Tabulation is shown below:

REVIEW FINAL ENGINEERING ASSESSMENT REPORT OF CH2M ON LIGHTHOUSE BEACH PIER, BAYFRONT PIER AND WETLANDS BOARDWALK

No action needed and none taken.

CONSIDER AUTHORIZING CH2M TO PROCEED WITH FINAL DESIGN AND CONSTRUCTION ADMINISTRATION OF THE BAYFRONT PENINSULA FISHING PIER RENOVATION PROJECT PER THE PRESENTED PROPOSAL

City Engineer/Community and Economic Development Official Weaver advised City Council that because early indications are that CDBG funds will not favor the funding of pier rehab, we don't see any advantage to wait on more information from GLO to start the design process. She said because FEMA is offering a 90% reimbursement, the difference between going the FEMA PA route and a potential GLO CDBG route is \$90,000 (10% of \$900,000). She commented that waiting on the CDBG route would delay the start on this pier by easily a year, if it's even awarded a grant.

Weaver recommend authorizing CH2M to proceed with the final design. She said Council can require that CH2M receive authorization from Council prior to advertising for bids. In that way, if Council later decides to delay the process, they can hold off on actually bidding the project until a later time.


